- 1) The Navajo Western Water District Board of Directors Meeting was called to order by President Dave Rogers on February 8, 2023, at 1:12p.m.
- 2) Roll call found the following Board Members present: President Dave Rogers, Treasurer Susan Smith, Secretary Vanna Morningstar, and Director Arnold Marquez. Vice President Charlene Baldwin was absent.
- 3) <u>Secretary reading of the minutes for January 11, 2023</u>
 President Dave Rogers asked if the minutes had any additions or corrections. Treasurer Susan Smith made a motion to accept minutes as read. Director Arnold Marquez seconded, and the minutes were approved.

4) Treasurer's Report

Treasurer Susan Smith reported a net profit \$4,815.16 for the month of January. The Treasurer's report was not available to the Board at this meeting. Office manager Jody McCoy explained the delay was due to the workload and answering customer questions regarding the new billing system.
