

# NAVAJO WESTERN WATER DISTRICT BOARD OF DIRECTORS REGULAR MEETING Wednesday, September 13, 2023 - 1:00 PM <u>MINUTES</u> (Approved 2023 Oct 11 BOD Mtg)

## I. Call To Order

The Navajo Western Water District Board of Directors Meeting was called to order by President Dave Rogers on Wednesday, September 13, 2023, at 1:15p.m.

# IV. Reading of Minutes of August 09, 2023 (Regular Board Meeting)

#### V. Treasurer's Report (Susan Smith, Treasurer)

Treasurer Susan Smith presented the 2023 July and August financial reports. The net profit for July is \$12,165.27. The net profit for August is \$9,482.46. Secretary Vanna Morningstar made the motion to approve the reports as presented, Vice President Gary Baldwin seconded, and the motion was unanimously accepted.

#### VI. Technician's Report (Tom Northup, Water Facility Operator)

Tom requested the purchase of a main pump motor as ours is 20yrs old. Vice President Gary Baldwin made the motion to purchase the pump, Secretary Vanna Morningstar seconded, and the motion was unanimously approved.

Water Overage Appeals (moved from Public Session)

Tom reported several customers had confirmed leaks. Both were toilet leaks and have been fixed. Secretary Vanna Morningstar made the motion to waive the overage fee for the Dickson's and the Merrill's, Vice President Gary Baldwin seconded, and <u>the motion was unanimously approved.</u>

Vice President Gary Baldwin made the motion for Director Rick Williams to fill the Treasurer's position. Secretary Vanna Morningstar seconded, and the <u>motion passed unanimously</u>.
