

NAVAJO WESTERN WATER DISTRICT BOARD OF DIRECTORS REGULAR MEETING Wednesday, December 13, 2023 - 1:00 PM MINUTES

I. Call To Order

The Navajo Western Water District Board of Directors Meeting was called to order by President Dave Rogers on Wednesday, December 13, 2023, at 1:05p.m.

II. Roll Call

Roll call found the following Board Members present: President Dave Rogers, Vice President Gary Baldwin, Treasurer Rick Williams, Director Dan Palmisano. Secretary Vanna Morningstar had an excused absence. A guorum has been established.

III. Public Session

The Special Meeting previously planned to approve and sign the Budget Resolution was moved to January 2024 Meeting due to state government changes occurring that affect the mill levy assessment from the Assessor. After discussion regarding certification deadlines, a Motion was made by Director Dan Palmisano to hold the January Special Meeting before the Regular Meeting on Tuesday January 9, 2024, Treasurer, Rick Williams, seconded –Unanimously approved.

IV. Reading/Approval of Minutes – Nov 08, 2023, Mtg

President Dave Rogers asked if the Minutes had any corrections or additions. **The motion to** approve the Minutes as presented was made by Director Dan Palmisano, Treasurer Rick Williams seconded, the Minutes were <u>unanimously approved</u>.
