### **MINUTES**

#### I. CALL TO ORDER

The Navajo Western Water District Board of Directors Meeting was called to order by Dave Rogers, President, on Thursday, May 8, 2025 @ 1:06pm.

#### II. ROLE CALL

The following Board members were present at the meeting: Dave Rogers-President, Gary Baldwin-Vice President, Rick Williams-Treasurer, Dan Palmisano-Director, Vanna Morningstar, Susan Smith-Accountant, Debra Palmisano-Secretary, Dave Rabideau-Water Operator. *A quorum has been established*.

III. **READING/APPROVAL OF MINUTES** – Debra Palmisano, Secretary to the Board. Thursday, April 10, 2025 (Regular) Board Meeting.

President, Dave Rogers asked if the Board Members had any corrections/additions to be made. MOTION TO ACCEPT THE MINUTES OF April 10, 2025 by Director, Dan Palmisano. MOTION 2<sup>ND</sup> by Vice-President, Gary Baldwin. Discussion. Vote. *Unanimously Approved*.

### IV. PUBLIC - COMMENTS:

- No Water Overages this month.
- V. *TREASURER'S REPORT*: Rick Williams, Treasurer (see attached)
  - Net Income is negative due to the five certified (death) accounts. Susan went back to November 2024 and changed accounts to Abandoned Meters (\$15/mo).
  - The adjustments were very high for the month.
  - Depreciation is up also.
  - MOTION TO ACCEPT THE FINANCIAL REPORT FOR APRIL 2025 BY Director, Dan Palmisano. 2<sup>ND</sup> MOTION by Rick Williams, Treasurer. Discussion. Vote. *Unanimously Approved*.

\*THE SWEARING-IN AND OATH OF OFFICE FOR NWWD BOARD OF DIRECTORS was performed by Dave Rogers, President, for Dan Palmisano and Vanna Morningstar. Dan Palmisano has accepted a 4-year term as Director. Vanna Morningstar has accepted the position of Vice-President for a 4-year term; replacing Gary Baldwin, whose term was up and will be leaving the board of Directors, effective May 8, 2025. "Congratulations!"

MOTION TO ACCEPT VANNA MORNINGSTAR AS VICE-PRESIDENT OF THE BOARD FOR A FOUR-YEAR TERM, (REPLACING GARY BALDWIN) by Rick Williams, Treasurer. MOTION 2<sup>ND</sup> by Dan Palmisano, Director. Discussion. Vote. <u>Unanimously Accepted</u>.

# VI. BOOKKEEPER'S REPORT: Susan Smith, Office Accountant

1. ZOOM Meeting with Brett Parsons (COLOTRUST) was scheduled for 1:30pm with BOD.

- Brett Parsons gave a presentation regarding COLOTRUST Local Government Investment Pool (oldest/largest in the State since 1985). Dividends applied daily.
- The Board must file a Resolution (Susan has an example). We will need two authorized signers (Bookkeeper & Board Member.)
- Once we have a log-in, COLOTRUST offers training on the portal. Presently COLOTRUST+ is at 4.4% for short-term investment. (The rate depends on the Fed rate).
- Susan suggested moving the Operations and Maintenance Accounts over to COLOTRUST.
- 2. Do we want to get JADE Internet at the NWWD office? (YES, the Board agrees we should). JADE SMART BIZ is \$120/mo for 100 mbs. Guests could log-on to our system. We could create a "Splash Page" for businesses. Susan will get a formal quote from JADE.
- 3. NWWD will need to make JADE aware they will be needed for the Pump Sites as well as the NWWD Office. <u>Suggestion</u>: We should switch to JADE and keep Huerfano Internet as back-up. (We should do away with CenturyLink).
- 4. PER SIGNED RESOLUTION 2025-03, IT IS RESOLVED TO REMOVE GARY BALDWIN AND MARY SAMARZIA-BONHAM FROM THE NWWD BANK ACCOUNTS; AND THE NWWD DESIGNATES DAVID WESLEY ROGERS, RICHARD WILLIAMS, DANIEL PALMISANO, VANNA MORNINGSTAR, SUSAN SMITH AND DEBRA PALMISANO AS AUTHORIZED SIGNERS ON ALL NWWD BANK ACCOUNTS.

# VI. **OPERATIONS REPORT**:

# WATER FACILITY OPERATOR REPORT for April 2025: Dave Rabideau, Water Operator

- The monthly water usage was half as much as last month.
- Pump #5 is working well pumping clean (9 gals/min).
- **B. OFFICE REPORT**: Debbie Palmisano, Office Secretary
  - Rules and Regulations: Must be updated to include in New Customer packets. Susan and I would like to suggest holding a Workshop, with the Board present, so we can go through and update all the Rules and Regulations. (We need new definitions for the Abandoned/Locked Meters).

# \*WORKSHOP SCHEDULED FOR MONDAY, MAY 19, 2025 @ 1:00pm at the NWWD Office\*.

- The F150 was dropped off Thursday, 5/1/25, for repairs and is still in the shop (estimated five days for repairs).
- Delinquent Accounts: We are making progress and have been getting payments.
  - o I will be typing up a form letter to be sent to delinquent accounts. (I am presently calling or emailing customers.)
  - o Susan and I have cleared five LIENS with the County that had never been filed.
- <u>SDA Workshop</u>: We are all registered for the workshop being held on Friday, June 13, 2025 @ 8:00am in Fountain. (Dave Rogers, Vanna, Rick, Dan P, Susan, Deb P).
- <u>District's Safety and Loss Prevention Grant 2025</u>: (Funds are still available for 2025). The funds can be used to reimburse up to 50% of eligible safety and loss prevention purchases. Is this something that would benefit the NWWD? YES.
  - We should order a couple of hard hats and safety vests. Dave Rabideau will order from Amazon and we will submit receipts.

## C. BOARD PRESIDENT'S REPORT: Dave Rogers, President

- Thank you to Susan and Debbie for all they are doing in the office. The office is running better and looks great.
- <u>Suggestion</u>: We can always reach out to other local Water Companies (Cuchara, Gardner) to see about procedures, etc. which may be advantageous to NWWD.
- <u>Suggestion</u>: We need to remove the "black" Drop-Box (for payments) outside the office because when it rains/snows, the checks are getting wet inside.

- Dave Rabideau removed the black drop box from the railing outside the office today.
- Thank you to Dave Rabideau and Keith Saint-Peter for doing a great job!
- We have a previous employee who is filing for Unemployment Compensation.

#### VII. OLD BUSINESS:

- Susan has an account she is asking for permission to write off. The account was *Certified*. Someone bought the property and didn't know there was a TAP on the property. Susan is asking for Board approval to wait until the Rules and Regulations are finished to send the new customer a letter.

## VIII. **NEW BUSINESS**:

- ERB Law: What are the Lawyers authorized to do? Susan sent them an email with no response.
  - Compliance Report @97% compliance. Do we need to be at 100% compliance?
    (Website is done by ERB Law. Couldn't this report be done by Susan?)
  - Call SDA regarding the Accessibility Report which needs to be submitted by July 2025. Do we need an Attorney to do the report? Or can we submit the report ourselves?
- Susan will be cleaning up the NWWD Website. She has begun to work on it.
  - Do we need to post all Resolutions on the website? (The last Resolution posted was from 2023).
  - The Exemption from Audit needs to be posted. Should the Annual Report and the Maps also be posted on the website?
- Dave Rabideau's official title should be ORC (OPERATOR RESPONSIBLE CHARGE)- per the State of Colorado. We will change Dave's title in our records.
- There are people building without permits. We need to be specific in the Rules and Regulations. \*\*If you know this is happening, you should report it to the Land Use Office.
- President, Dave Rogers stated that this will be Gary Baldwin's last Board meeting. Gary will be greatly missed! Thank you for all you have done for the NWWD over the years! We will be having cake and ice cream after the meeting.
